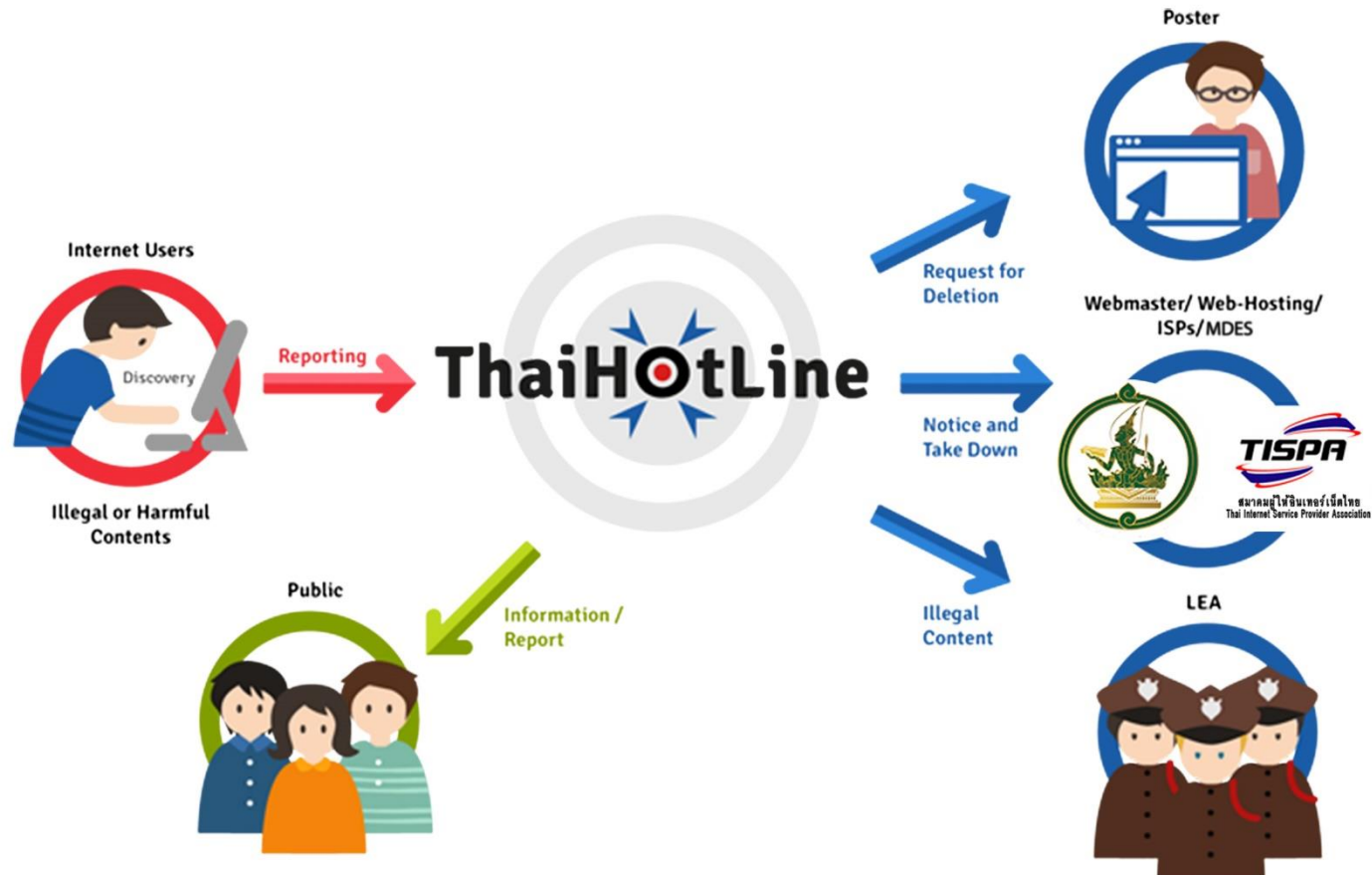

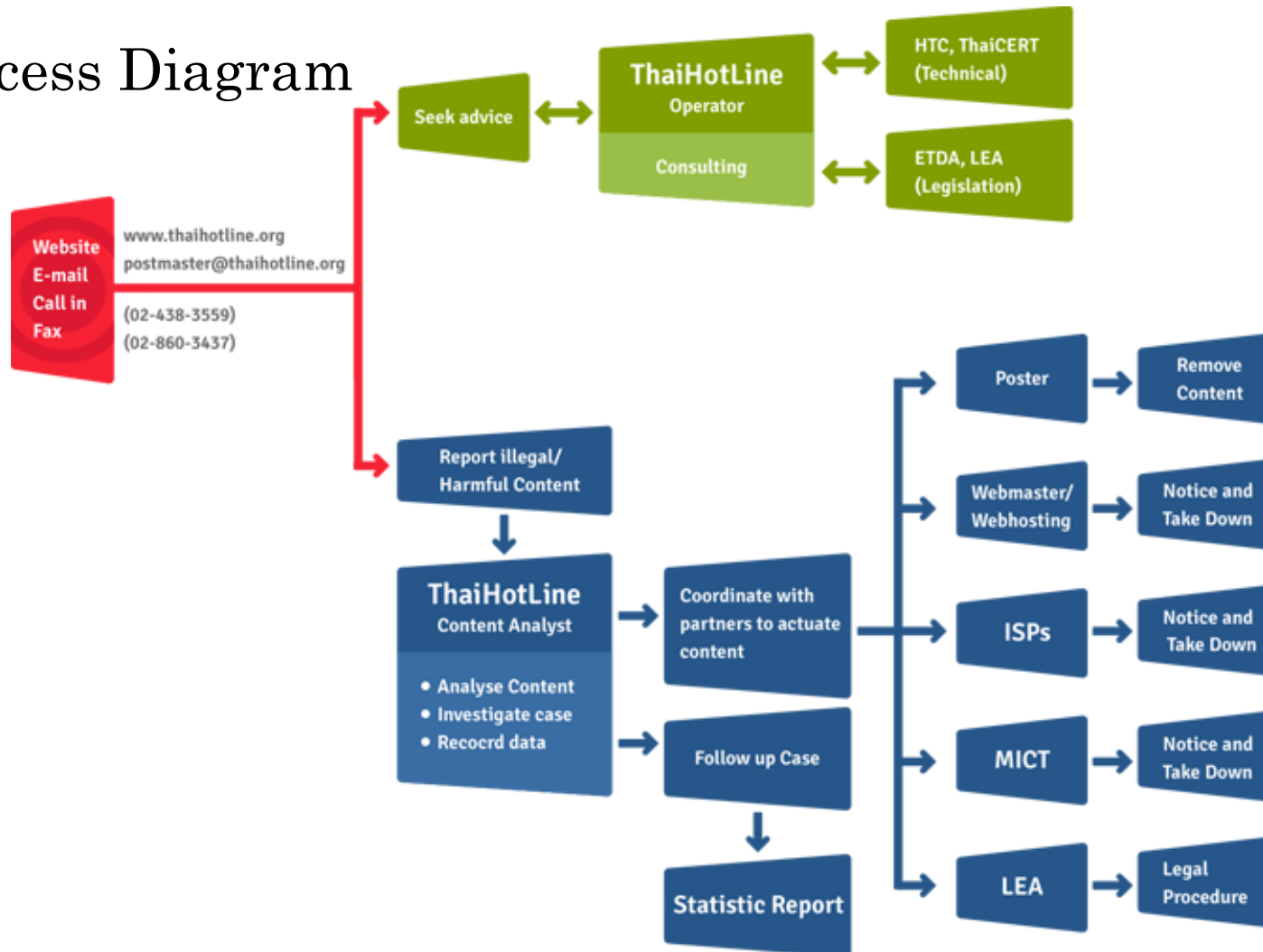

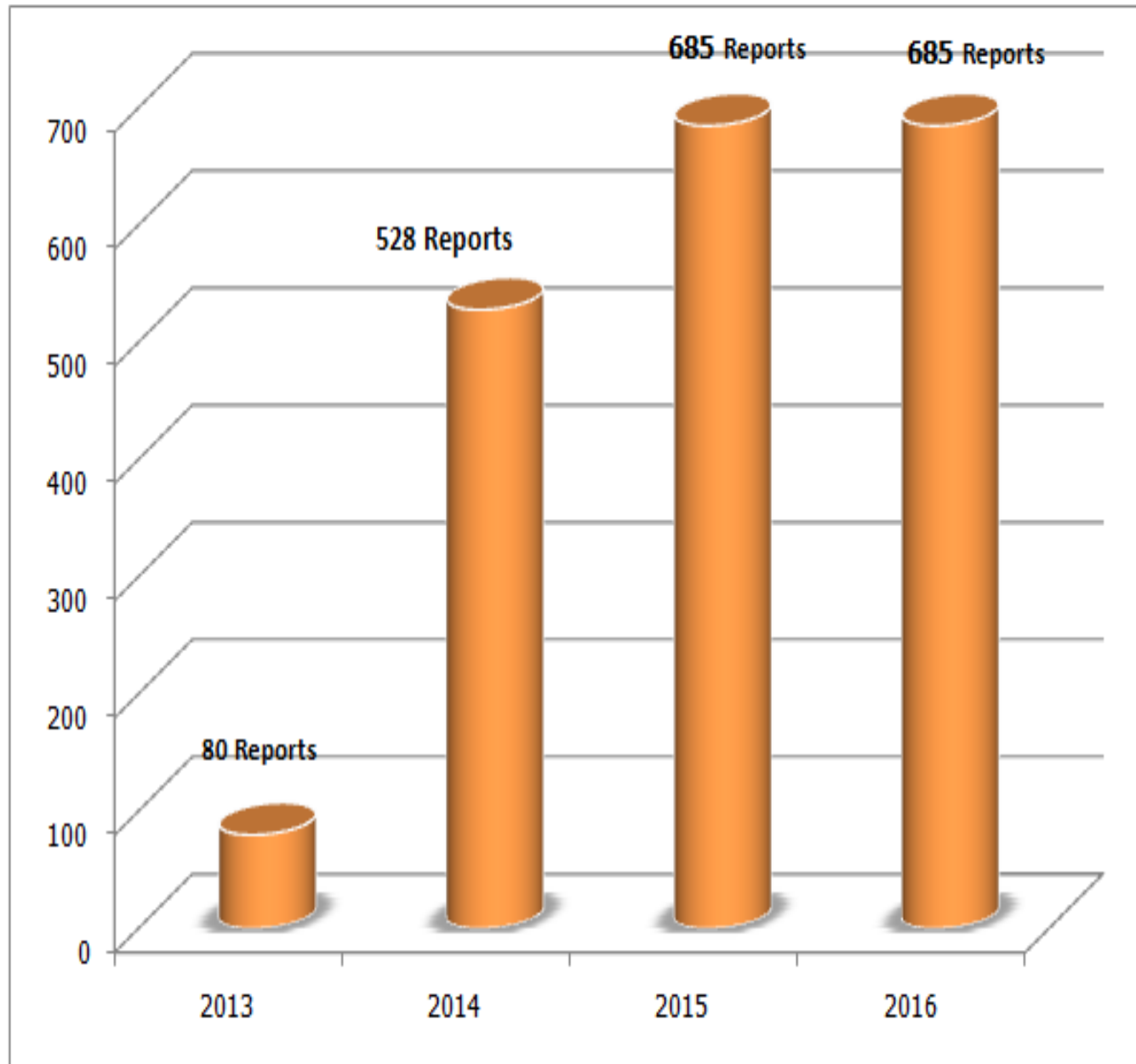

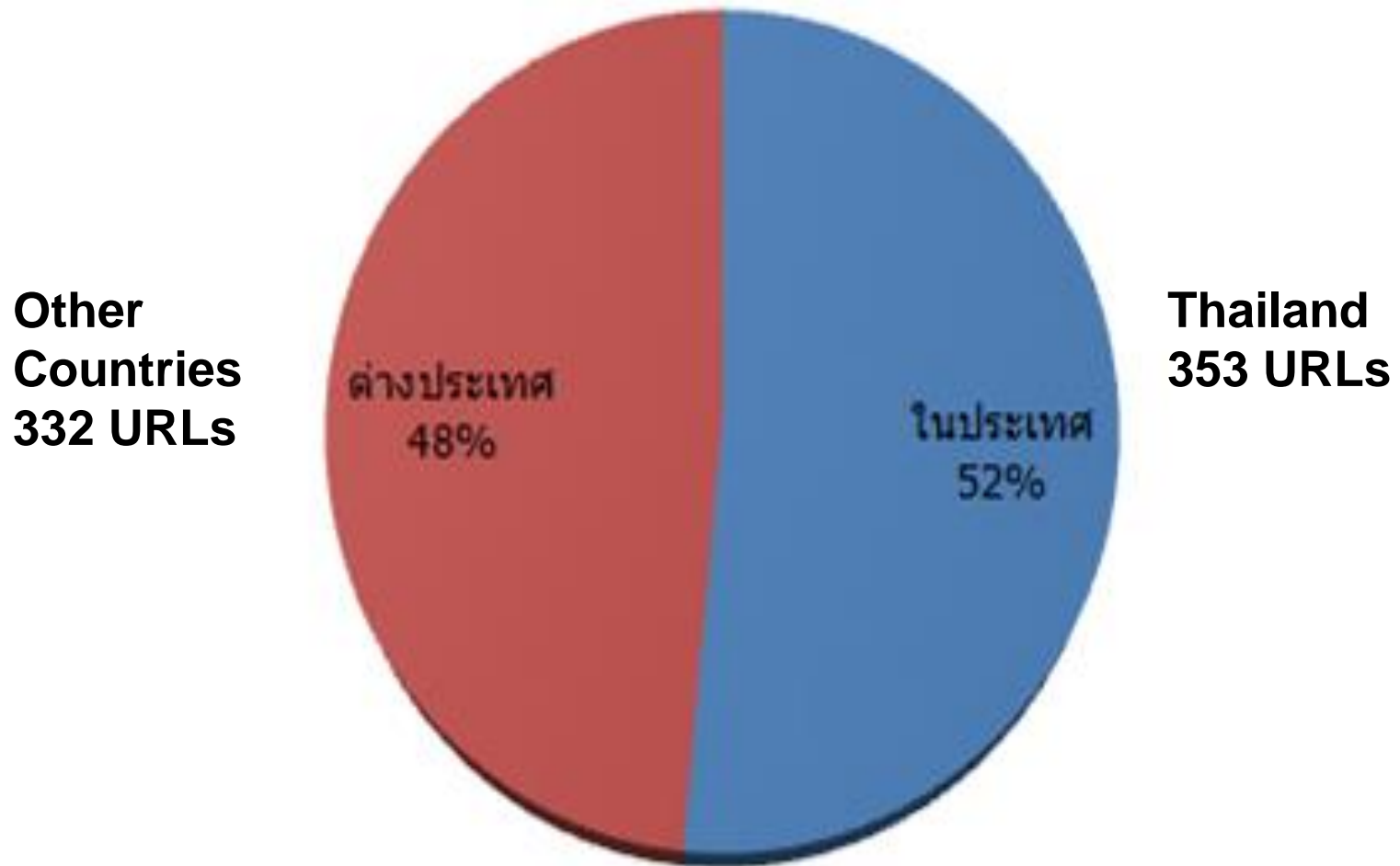

ThaiHotline : Number of URLs confirmed to contain CSAM



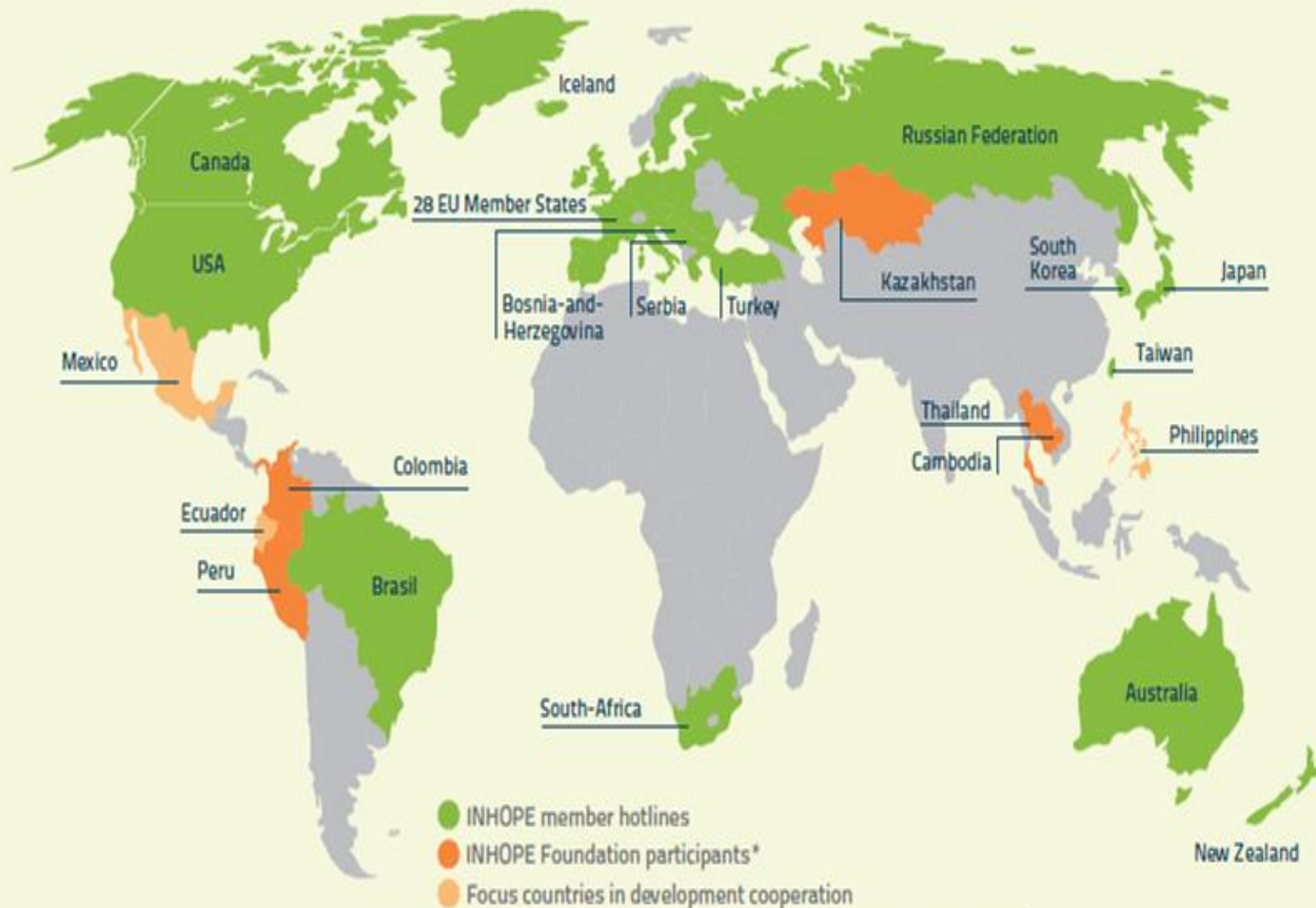
ThaiHotline : Number of URLs in 2016

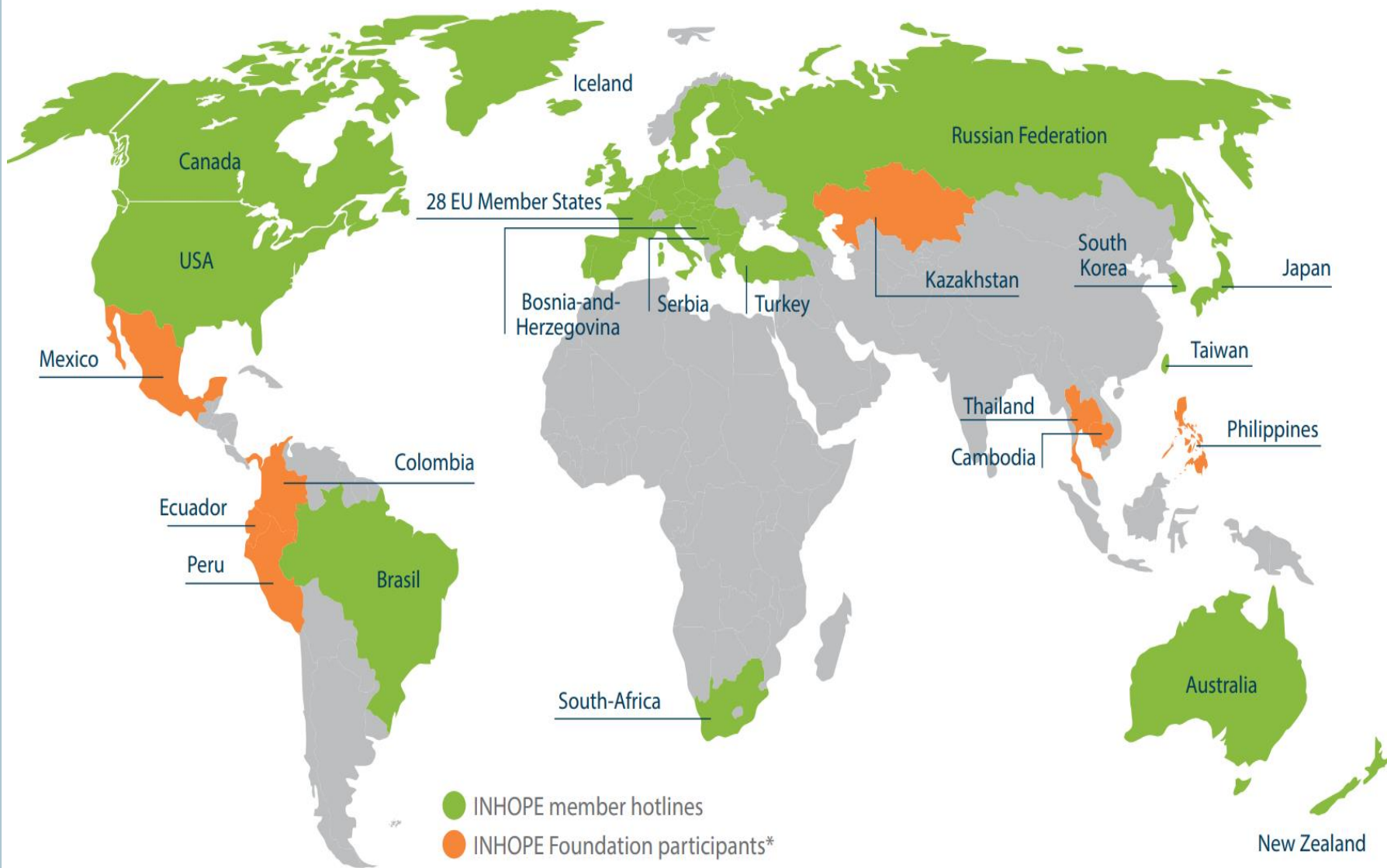

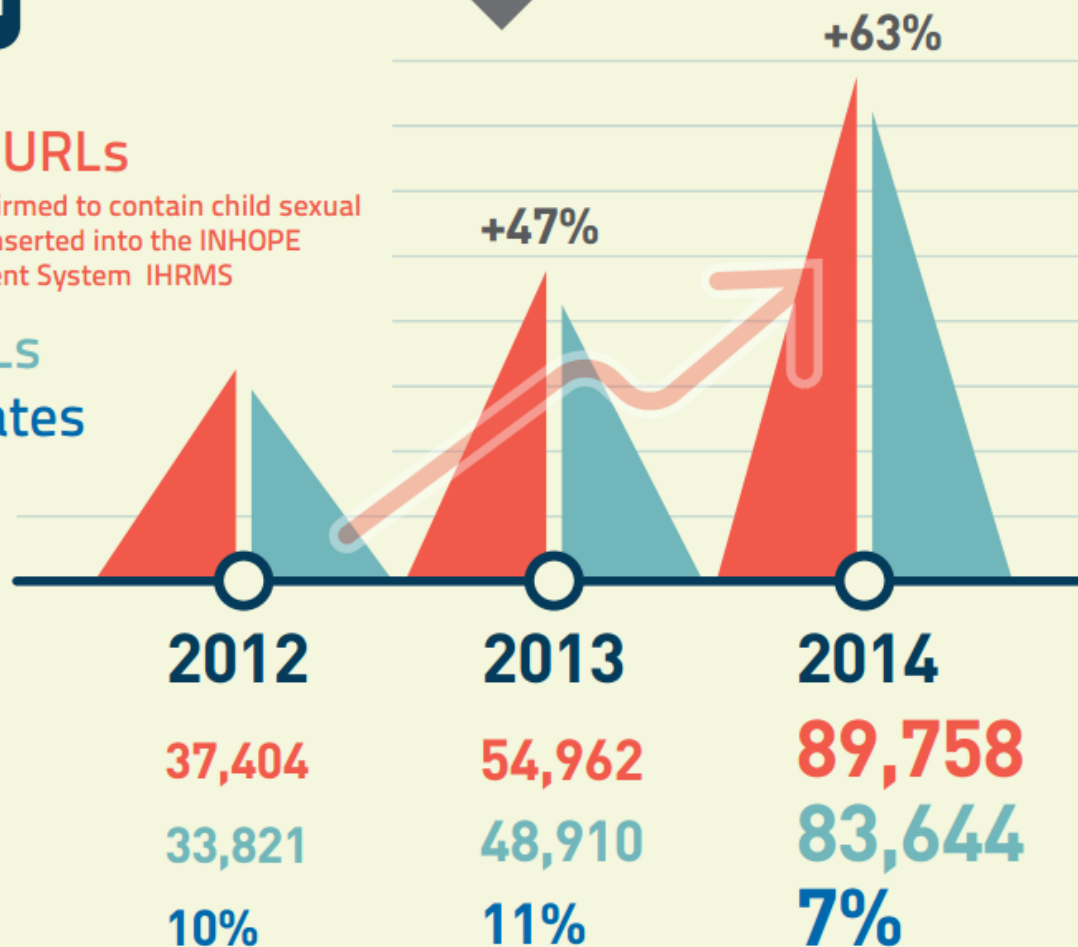

What we achieved in 2015: Facts, Figures and Trends

During the first 10 months of 2015 (1st January to 31st October) INHOPE Hotlines used the legacy IHRMS (INHOPE Report Management System) for the exchange of reports and gathering data. The data shown below are from the IHRMS and thus cover the first 10 months of 2015. As part of the LOT2 EU funded project INHOPE developed a new technical infrastructure for Hotlines which resulted in the launch of the ICCAM system. ICCAM was run on an initial pilot / test basis during early 2015 and went live across the network on 1st November 2015.



Reports

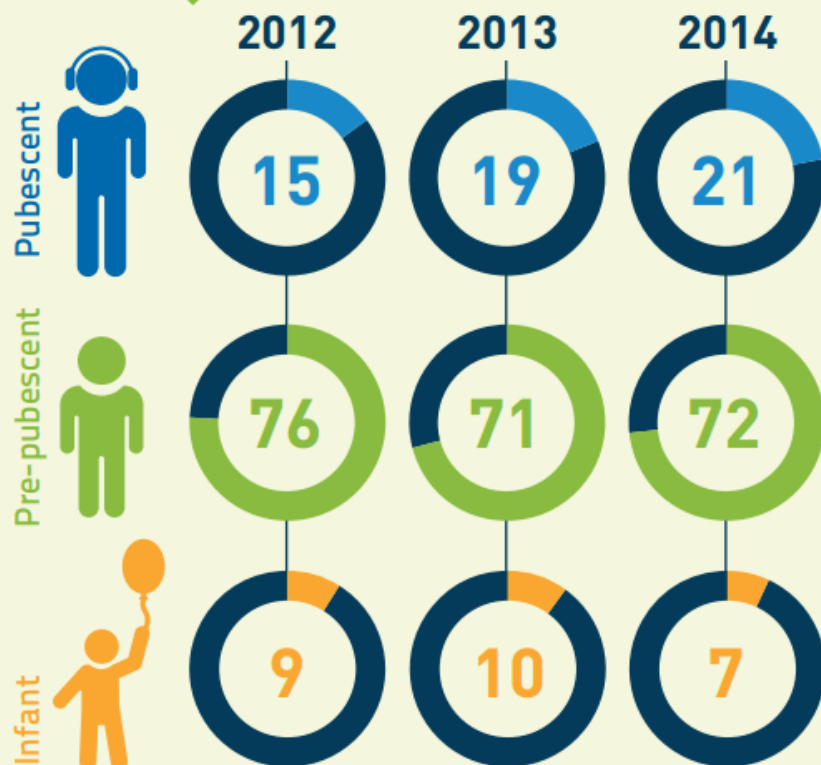
During the first 10 months of 2015 INHOPE Hotlines processed reports involving 96,334 URL's with confirmed CSAM content. This represents an increase of 7.3% when compared to the full 12 months of 2014.

Average Number of CSAM reports per month

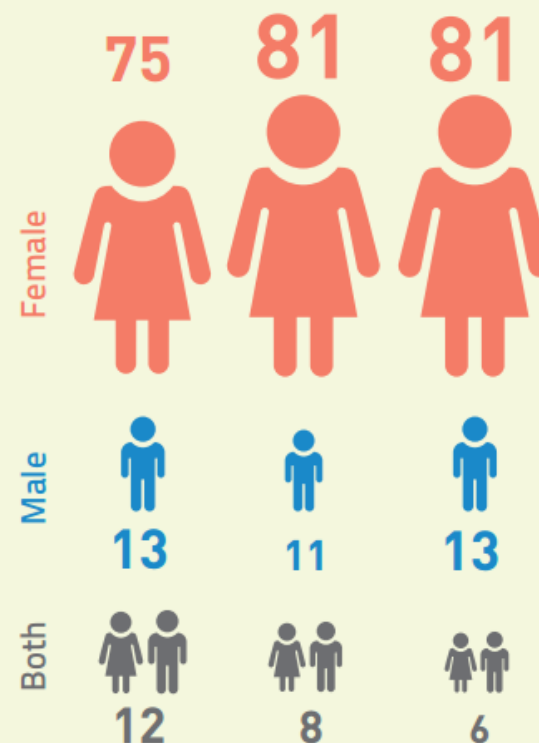

Age Group %

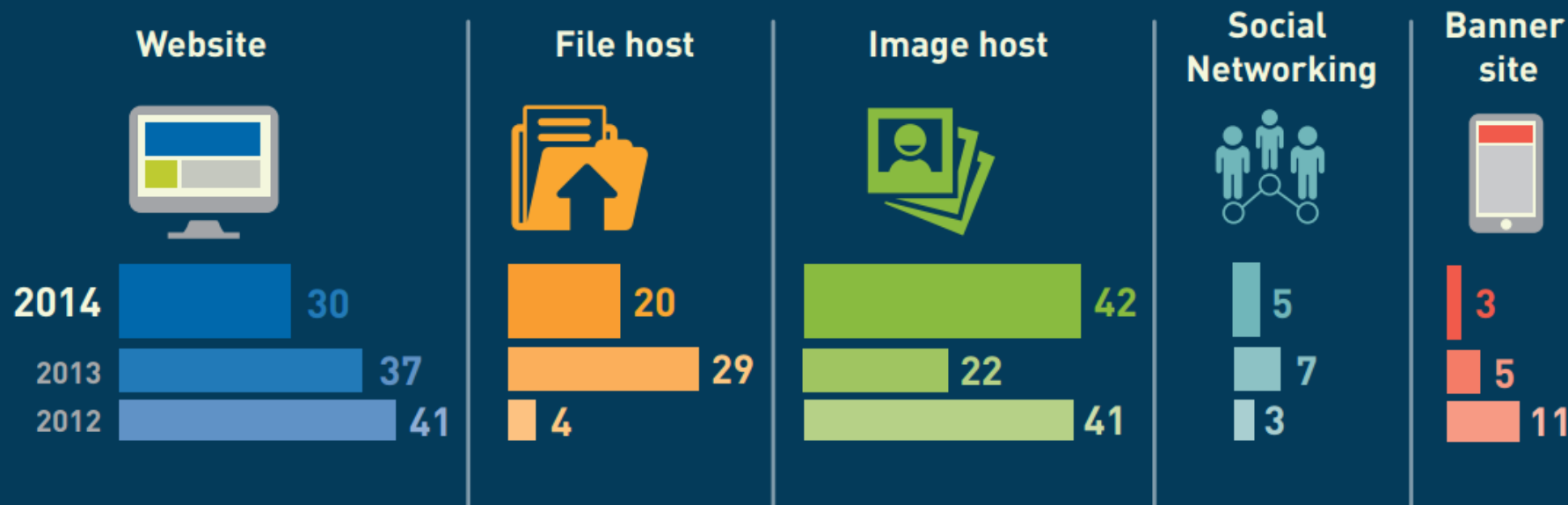

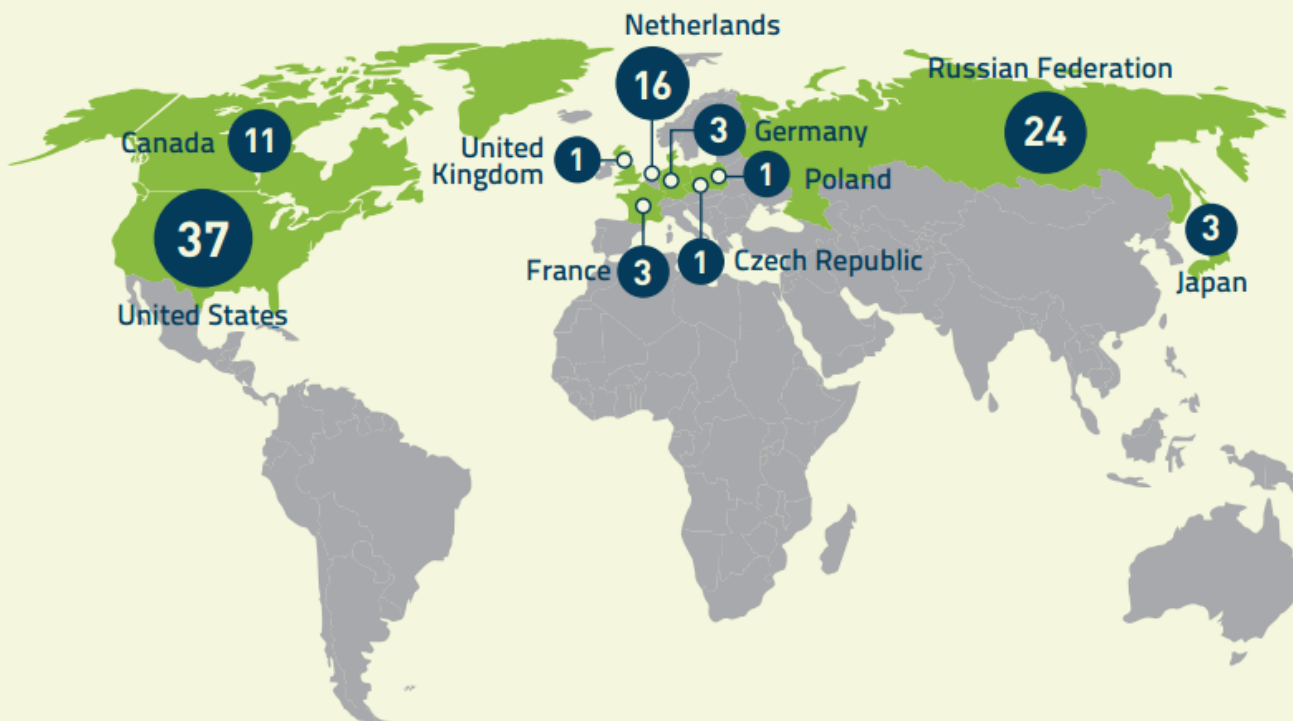

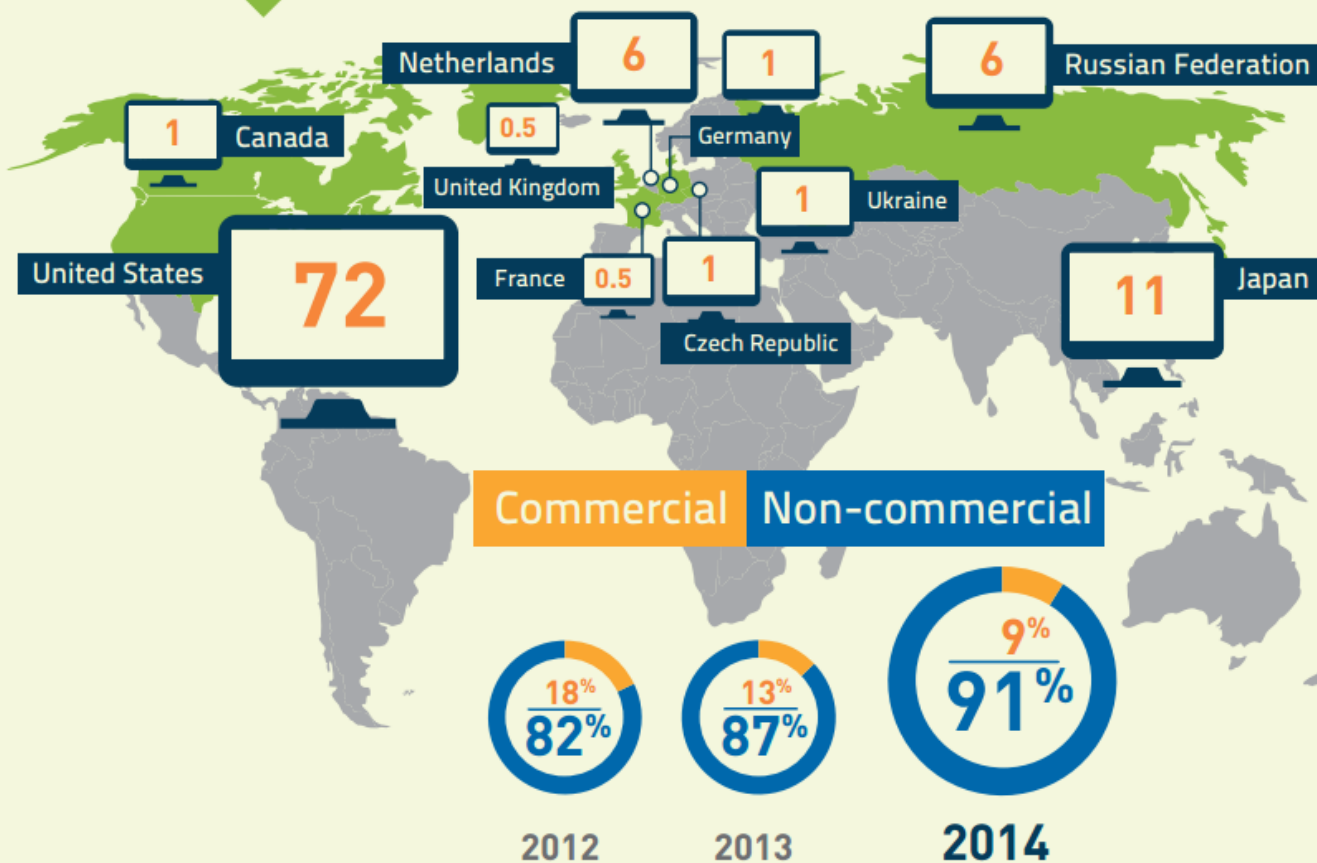

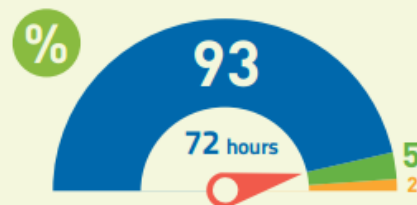

EUROPOL MAJOR ONLINE CHILD SEXUAL - ABUSE OPERATION LEADS TO 368 ARRESTS IN EUROPE

May 08, 2017

Yet another example of the need for international action to tackle online child sexual abuse.

Earlier this week, the lead administrator of Playpen, one of the world's largest child sexual abuse websites with more than 150 000 users around the world, was convicted to serve 30 years in prison in the United States. The takedown of Playpen led to Operation Pacifier, one of the largest and most complex investigations ever undertaken in this field. So far, in Europe alone, 368 suspected child sex abusers have been arrested or convicted.



Cybertip.ca success - the largest luring and child pornography case known in Canada

May 03, 2017

In Spring of 2015, Cybertip.ca received a report from a concerned parent regarding an incident involving his/her child. The youth was coerced to share sexual images with an online user who represented himself/herself as a teenager. The suspect subsequently threatened to distribute the images online if the youth did not comply with his demands for more images. A Cybertip.ca analyst completed various supplemental searches and forwarded the information to the Toronto Police Service. Further investigation by the Toronto Police Service led to the suspect (an adult male) being identified, arrested, and charged with over 400 luring, making and possessing child pornography and extortion charges involving multiple counts in Toronto and Quebec. The suspect subsequently pled guilty to offences against over 80 victims (some of whom were not identified), resulting in over 270 convictions. The remaining charges were dropped.

EUROPOL - Three suspects arrested by Romanian police for the sexual abuse & exploitation of a 3 year old child

Congratulations to our law enforcement partners EUROPOL

They successfully supported the Romanian law enforcement authorities in a case of child sexual abuse and exploitation, safeguarding a 3-year-old minor. During two house searches on 27 April 2017, the Romanian Police arrested three suspects. One man (aged 29) is suspected of sexually assaulting a 3-year-old child, and producing and distributing images of this sexual abuse online. The other two suspects are the parents of the child who are suspected of facilitating the sexual exploitation of their child in exchange for various amounts of money. During the house searches several data storage devices and mobile phones were seized.

At the request of the Romanian Prosecutor's Office, the three suspects are currently detained and judicial proceedings are ongoing.

Europol's role was to provide relevant intelligence about the suspects' criminal activities to the Romanian authorities. The investigation in Romania was carried out by the Directorate for Combating Organised Crime, coordinated by prosecutors from the Directorate for Investigating Organised Crime and Terrorism, with specialised support from the Directorate of Special Operations, Romanian Gendarmerie and Europol.

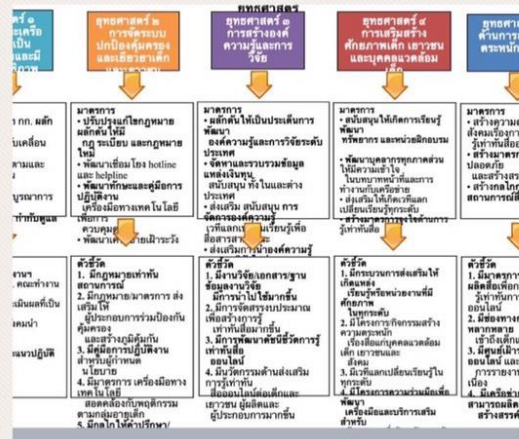






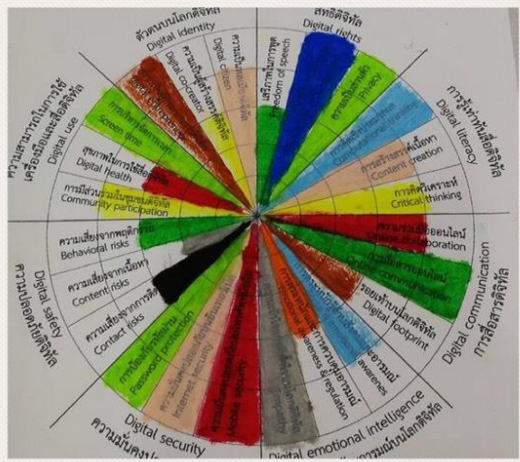

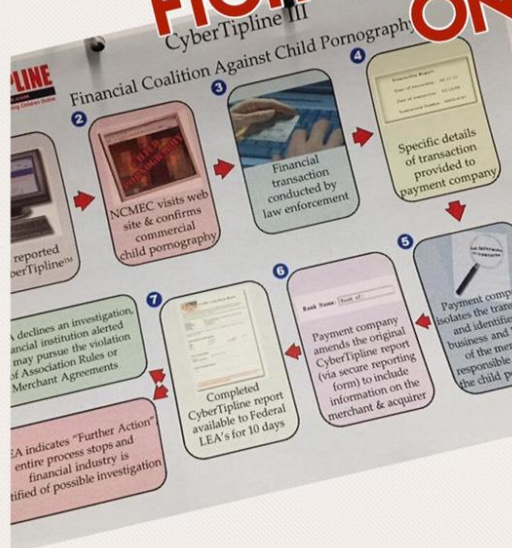
